Dear Mr. Mallard:

Thank you for your February 13 letter requesting an official interpretation of the Manual on Uniform Traffic Control Devices (MUTCD). Specifically, you asked whether "red light cameras" are traffic control devices.

Section 1A.13 of the MUTCD defines "traffic control device" as follows:

Traffic Control Device—a sign, signal, marking, or other device used to regulate, warn, or guide traffic, placed on, over, or adjacent to a street, highway, pedestrian facility, or shared-use path by authority of a public agency having jurisdiction.

A "red light camera," typically called a "photo enforcement system" in the transportation industry, does not regulate, guide, or warn traffic. The traffic signal itself regulates traffic. A red traffic signal indication is what prohibits drivers from entering the intersection. A red light camera is an electronic device that performs the same function as a police officer, detecting violations of the traffic signal and issuing citations for such violations, but doing so in an automated rather than human fashion.

The MUTCD does include standards for signs that may be used to warn road users that photo enforcement systems are in operation. Such signs are traffic control devices under the definition cited above. The photo enforcement systems or "red light cameras" are not traffic control devices and are not governed by provisions of the MUTCD.
